

**Pilot
Release from Liability**

The undersigned has requested permission to park and operate an ultralight or other aircraft on real estate being used by the sponsors of this fly-in and has further requested permission to land upon, take off from, and otherwise operate said aircraft on, about, and above this real estate.

In order that I be permitted to engage in any activity relates to rides, flights, instructions, taxiing, sales, demonstrations, maintenance, or other operation involving ultralight or other type aircraft on, above, or about said real estate, I willingly take upon myself and specifically release the real estate owners and sponsors of the fly-in from any and all responsibility for any claim of injury, loss, or property damage which may occur to or be inflicted upon me or others as a result of or during any of the above-mentioned activities.

The undersigned releaser unconditionally agrees to the following:

1. I agree that no warranties, expressed or implied, have been given concerning the condition of the real estate, the weather, or airspace conditions in or about the real estate, or the possible conditions of flight safety existing on, over, or about the real estate.

2. I acknowledge that the facilities, the take off and landing areas, and the departure and approach paths do not meet normal standards for airports and that I assume full responsibility for determining the suitability and safety of my aircraft before each and every operation and for determining my ability to operate the aircraft safely on, over, or about the real estate.

3. I assume full responsibility and liability for the operation of my aircraft by others when operating on, over, or about this real estate.

4. I acknowledge that no warranties, expressed or implied, have been given by the real estate owners or the sponsors of the fly-in concerning the safety of any flight, the fitness of any pilot, or the fitness or safety of any aircraft and that any flight or other activity conducted on, above, or about this real estate is attempted solely at my own risk.

5. I acknowledge that there is no medical service of any kind located on or about this real estate and that I assume responsibility for my own safety and for the safety of any guest I might bring onto the real estate.

6. I acknowledge that there is no security nor any responsibility or liability with regard to the real estate owners or the sponsors of the fly-in for the protection or security of any aircraft or personal property brought onto this real estate.

7. I agree not to attempt to use any part of the real estate or airspace until I have become familiar with any hazard or condition which may exist in that area.

8. I certify that I am over eighteen (18) years of age, and if married, have executed this document on behalf of myself, my spouse, and the marital community which they comprise.

9. I unconditionally agree that the contents of this document will be forever binding upon the releaser and the spouse, dependents, parents, or legal guardians, heirs, personal representatives, and estate of the releaser.

10. I acknowledge that I have read this entire document, including the flight information briefing on the reverse side, understand their contents, know of the truthfulness thereof, and have been provided a copy of same.

NOTE: If under eighteen (18) years of age, approval and signature of a parent or legal guardian is required.
